SEASONS

- 1. Winter Season is from November through February.
- 2. Non-Winter Season is from March through October.

TIME PERIODS - WEEKDAYS

- 1. The Peak Time Period is from 7 a.m. to 12 p.m. and 4 p.m. to 8 p.m.
- 2. The Shoulder Time Period is from 12 p.m. to 4 p.m.
- 3. The Off-Peak Time Period is from 8 p.m. to 7 a.m.

TIME PERIODS - WEEKENDS and HOLIDAYS

- 1. The Shoulder Time Period is from 7 a.m. to 8 p.m.
- 2. The Off-Peak Time Period is from 8 p.m. to 7 a.m.

*As a result of the Energy Policy Act of 2005, Daylight Saving Time (DST) in the U.S. will begin on the second Sunday in March and end the first Sunday in November. To accommodate this change, Time-Of-Use Time Periods have been changed according to the schedule below for the two time periods: 1) the Second Sunday in March through the First Sunday in April, and 2) the Last Sunday in October through the First Sunday in November).

TIME PERIODS - WEEKDAYS (Due to DST changes)

- 1. The Peak Time Period is from 8 a.m. to 1 p.m. and 5 p.m. to 9 p.m.
- 2. The Shoulder Time Period is from 1 p.m. to 5 p.m.
- 3. The Off-Peak Time Period is from 9 p.m. to 8 a.m.

TIME PERIODS - WEEKENDS and HOLIDAYS (Due to DST changes)

- 1. The Shoulder Time Period is from 8 a.m. to 9 p.m.
- 2. The Off-Peak Time Period is from 9 p.m. to 8 a.m.
